### Admission criteria and weightings

- (1) Academic performance (35%)
- (2) Conduct and Co-curricular Activities (35%)
- (3) Performance in interview (30%) Individual and group interviews will be conducted to gauge the overall abilities of students in languages, general knowledge, social aptitude, and life skills.

#### Interview

All applicants will be invited to attend an interview held on 9<sup>th</sup> March 2024 (Saturday) and they will receive notification letters issued by our school. In case a red/black rainstorm warning signal is issued or Tropical Cyclone Warning Signal No. 8 or above is hoisted on 9<sup>th</sup> March 2024 (Saturday), the admission interview will be postponed until 16<sup>th</sup> March 2024 (Saturday).

#### Documents to be submitted

- (1) School application form;
- (2) EDB's Application Form for S1 Discretionary Places; \*
- (3) Photocopies of all P.5 and P.6 half-yearly school reports;
- (4) Photocopies of supporting documents on participation and performance in extra-curricular activities, certificates and awards;
- (5) Two self-addressed envelopes affixed with sufficient postages.

\* The form has to be filled out with a <u>blue or black</u> ball pen, while the parent slip will be stamped and returned to parents.

### Application results

According to EDB's instructions, we will notify successful DP applicants by mail and phone on 27<sup>th</sup> March 2024. The finalized results will be released by EDB on 9<sup>th</sup> July 2024.

### Remarks

- (1) Recommendation letter from the headmaster or the primary school is not required.
- (2) In accordance with the Personal Data (Privacy) Ordinance, parents/guardians have the right to access and correct the personal data on the application from and other submitted documents.
- (3) The application forms will be archived in our school for records and other education-related purposes. The information on the form may be provided to government departments (such as the Education Bureau, etc.) on request.
- (4) All personal data will be destroyed if the application was unsuccessful.
